



Good afternoon,

Effective Wednesday, September 22, 2021, all Members and guests who are eligible for vaccination (12 yrs. of age and older) must be Fully Vaccinated (see definition below) against COVID-19 to gain access to the indoor dining facility (the restaurant).

Entry

- Provide the required proof of identification.
- Show physical or digital proof of full vaccination (*double dose plus 14 days*) via vaccination receipt.
 - A person is considered "Fully Vaccinated" fourteen (14) days after having received two (2) doses of the approved two (2) dose vaccines (Pfizer, Moderna and Astra Zeneca) or one (1) dose of the approved single dose vaccine (Janssen/Johnson & Johnson). A person who has received two (2) different vaccines (such as a first dose of Oxford/AstraZeneca followed by a second dose of Pfizer or Moderna) is deemed fully vaccinated.

Should an individual choose not to share the required information, they will not be permitted to enter businesses or organizations that require proof.

Exemptions

- Individuals who are exempt:
 - Children under 12 years of age are exempt.
 - Patrons under 18 years of age entering a sports and recreational facility for the purpose of actively participating in an organized sport (applies to training, practices, games and competitions) are exempt.
 - Patrons with a medical exemption are required to present identification and a written document stating the individual is exempt for a medical reason to the business or organization.
 - *Note: medical exemptions must be signed by a physician (designated as "MD") or by a registered nurse in the extended class (designated as "Registered Nurse (Extended Class)", "RN(EC)", "Nurse Practitioner" or "NP")*
- Areas of exemption:
 - Use of indoor washroom
 - To make a retail purchase in the Pro Shop;
 - While placing, picking up, or paying for an order;
 - As may be necessary for the purposes of health and safety.
 - NOTE: All other public health measures (e.g., masking and physical distancing) continue to apply to patrons.

We will continue to send you updates as more information becomes available. Please understand that we are required by law to adhere to these policies that are mandated by the Ontario Government in a hope to continue to keep Members and guests as safe as possible.

Our staff are required to enforce this in our indoor dining areas, so we kindly ask that you please continue to treat them with respect.
